WHY DEFAULT JUDGMENT AND PERMANENT INJUNCTION
SHOULD NOT BE ENTERED AGAINST DEFAULTING DEFENDANTS**

Upon the accompanying Affidavit of Brian Samuel Malkin in Support of Plaintiff's Application for an Order to Show Cause Why Default Judgment and Permanent Injunction Should Not be Entered Against Defaulting Defendants ("the Affidavit"), the Certificate of the Service of the Amended Summons and Amended Complaint, the Certificate of the Clerk stating that no answer has been filed in this Action, the Memorandum of Law in Support, and upon all other pleadings and papers filed in this Action,

IT IS HEREBY ORDERED that the Defendants identified on Attachment A hereto (collectively "Defaulting Defendants") show cause before the Honorable Gregory H. Woods, in

Courtroom 12C of the United States District Court for the Southern District of New York, at 500 Pearl Street, New York, New York on March 6, 2019 at 2p m., or such other time that this Court deems appropriate, why an order should not be issued pursuant to Rule 55 of the Federal Rules of Civil Procedure for the entry of a default judgment against each Defaulting Defendant awarding Plaintiff ~~permanent injunctive relief, the total sum of \$~~ _____

~~(\$ _____)~~ in statutory damages and post-judgment interest, and any other ancillary equitable relief as this Court may deem just and proper (“the Show Cause Hearing”).

IT IS FURTHER ORDERED that opposing papers, if any, shall be filed electronically with the Court and served on Plaintiff's counsel on or before February 27, 2019, by ~~delivering copies thereof to the office of Ference & Associates LLC at 409 Broad Street,~~ Pittsburgh, Pennsylvania, 15143, Attn: Stanley D. Ference III. Plaintiff shall file any Reply papers on or before March 4, 2019.

IT IS FURTHER ORDERED that the service of a copy of this ORDER TO SHOW CAUSE and its supporting papers, including the Affidavit and Memorandum of Law in Support (collectively, “the OSC Papers”), shall be made on each Defaulting Defendant by


February 13, 2019, and deemed effective as to all of Defaulting Defendants if it is completed by one the following means: delivery of: either (i) a PDF copy of the OSC Papers, or (ii) a link to a secure website (such as Dropbox.com, NutStore.com, a large mail link created through RPost.com and via website publication through a specific page dedicated to this Lawsuit accessible through ferencelaw.com) where each Defaulting Defendant will be able to download a PDF copy of the OSC Papers to Defaulting Defendants' email addresses as presently known to Plaintiff.

If Defaulting Defendants fail to appear at the Show Cause Hearing or otherwise fail to file a response to this ORDER TO SHOW CAUSE, a default judgment will be entered against each of the Defaulting Defendants.
