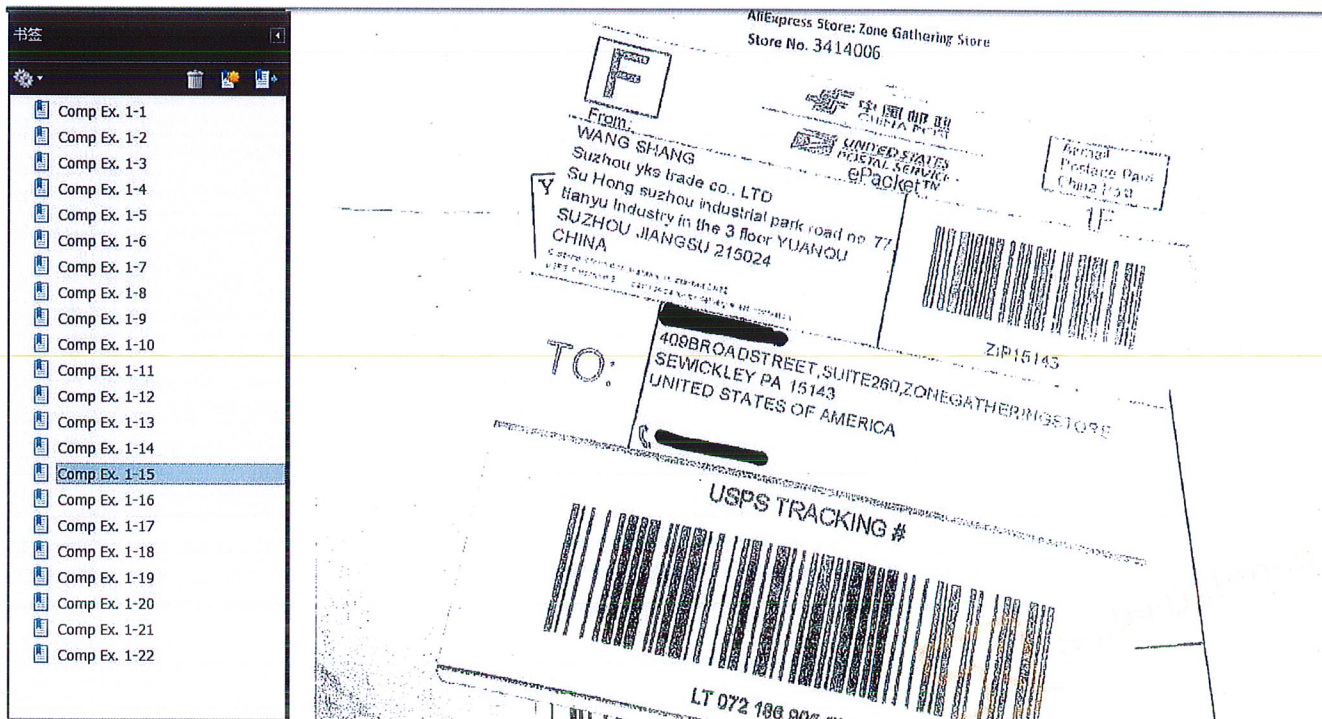

This new law firm can be considered as the GBC in 2014. It is characterized by not only taking screenshots but also real orders. The following is a proof of the package photo given by this law. Another feature is that there are very few shops currently reported, currently killing. Little effort.



At <https://sellerdefense.cn/search> conference, you can know that this law has previously acted as a NEGG egg stripper. After these cases, I believe that this law firm will improve efficiency and cause greater damage to the seller community. Threat.
