On this day the Court considered Plaintiffs' *Ex Parte* Motion to Extend the Temporary Restraining Order, Continue the Order to Show Cause Hearing, and Modify Schedule. ORDER

A. Defendants are hereby ORDERED to show cause before this Court in the United States District Court for the Western District of Pennsylvania, the U.S. Courthouse, 700 Grant Street, Pittsburgh, Pennsylvania in Courtroom No. 6A on the 17th day of July at 11:30 A.m. or at such other time that this Court deems appropriate, why a preliminary injunction, pursuant to FRCP 65(a), should not issue. The Temporary Restraining Order (ECF No. 15) shall remain in effect until ~~further Order of this Court.~~ 11:30 A.M. EDT,


July 25, 2019, unless otherwise ordered by this Court.

B. IT IS FURTHER ORDERED that opposing papers, if any, shall be filed electronically with the Court and served on Plaintiffs' counsel by delivering copies thereof to the office of Ference & Associates LLC at 409 Broad Street, Pittsburgh, Pennsylvania 15143 before 2:00 p.m. EDT July 15, 2019. Plaintiffs shall file any Reply papers on or before 2:00 p.m. EDT, July 16, 2019.

C. IT IS FURTHER ORDERED, as sufficient cause has been shown, service shall be made in accordance with the Alternative Service Order (ECF No. 17) within twenty four hours after Plaintiffs have received notice of PayPal's compliance with Paragraphs I (A)(7) of the June 27, 2019 Order (ECF No. 15). Plaintiffs shall also serve a copy of this Order upon Defendants when service by Alternative means is made.
