PLAINTIFFS' STATUS REPORT

Plaintiffs Doggie Dental Inc. (“Doggie Dental”) and Peter Dertsakyan (“Dertsakyan”) (collectively, “Plaintiffs”), hereby file this Status Report in response to the Court’s Order of December 26, 2019.

Plaintiffs intend to pursue this action against the defendants remaining in the case. Within thirty (30) days, Plaintiffs will file their Motion for Default Judgment seeking both equitable relief and an award of damages. At the same time the Motion is filed, Plaintiffs will also file an Exhibit List consisting of documents previously made of record. Upon receipt of an Order setting a hearing date on the Motion and a deadline for the defendants to respond to the Motion, Plaintiffs will serve a copy of the Order upon the defendants remaining in the case. At the hearing, Plaintiffs will be relying upon the papers submitted in support of the Motion and will move to admit the exhibits appearing on the Exhibit List; Plaintiffs will not be calling any witnesses. Plaintiffs do not expect any of the defendants to appear at the hearing on the Motion for Default Judgment. In the experience of Plaintiffs’ counsel the hearing should take less than fifteen (15) minutes.

At the time the lawsuit was filed there were 102 named defendants. Each of the defendants has been served with the Summons and Complaint. A Return of Service appears in the records at Dkt. No. 32.

A number of defendants have been dismissed, leaving 55 defendants currently in the case. None of these 55 defendants has filed an answer or otherwise responded to the Complaint. The Clerk of Court has entered default against each of the 55 defendants (hereinafter, “the Defaulting Defendants”). The Clerk’s Entry of Default appears in the record at Dkt. Nos. 43 and 44.

At the time the Summons and Complaint were served, each of the defendants was also served with discovery, including Requests for Admission. None of the Defaulting Defendants have responded to the discovery.

All the named defendants in the lawsuit appear in the tabular Schedule “A” submitted herewith. All dismissed defendants are marked as “Terminated”; all other defendants are marked as “Defaulted”.
