On January 17, 2020, in accordance with the Order on Plaintiffs' Ex Parte Motion for An Order Authorizing Alternative Service on Defendants Pursuant to Federal Rule of Civil Procedure 4(f)(3) ("Alternative Service Order"), Plaintiff made service, via e-mail, of the Temporary Restraining Order and Order Extending Temporary Restraining Order and Show Cause Hearing upon all the Defendants.

6. On January 18, 2020, an error message was received from the email server indicating that the email sent to Defendant No. 134 (Tevolt) was not deliverable. The alternative service upon Defendant Tevlot was then accomplished using the email system provided by Amazon which did not return any delivery error message.
